

2018 SC Refund Deadlines

\$75 deposit to reserve a spot is NON REFUNDABLE, regardless of cancelation date or reason.

Session 1, June 18-22, 2018, if you cancel:

On May 28 or before: You will be charged the \$75 cancelation fee, then you will receive a refund of the remaining funds you have paid.

On May 29-June 10: You will be charged the \$75 cancelation fee, then you will receive a 50% refund of the remaining funds you have paid.

On June 11 or later: NO refund will be issued.

Session 2, June 25-29, 2018, if you cancel:

On June 4 or before: You will be charged the \$75 cancelation fee, then you will receive a refund of the remaining funds you have paid.

On June 5-17: You will be charged the \$75 cancelation fee, then you will receive a 50% refund of the remaining funds you have paid.

On June 18 or later: NO refund will be issued.

Session 3, July 2-6, 2018, if you cancel:

On June 11 or before: You will be charged the \$75 cancelation fee, then you will receive a refund of the remaining funds you have paid.

On June 12-June 24: You will be charged the \$75 cancelation fee, then you will receive a 50% refund of the remaining funds you have paid.

On June 25 or later: NO refund will be issued.

Session 4, July 9-13, 2018, if you cancel:

On June 18 or before: You will be charged the \$75 cancelation fee, then you will receive a refund of the remaining funds you have paid.

On June 19-July 1: You will be charged the \$75 cancelation fee, then you will receive a 50% refund of the remaining funds you have paid.

On July 2 or later: NO refund will be issued.

Session 5, July 16-20, 2018, if you cancel:

On June 25 or before: You will be charged the \$75 cancellation fee, then you will receive a refund of the remaining funds you have paid.

On June 26 –July 8: You will be charged the \$75 cancellation fee, then you will receive a 50% refund of the remaining funds you have paid.

On July 9 or later: NO refund will be issued.

Session 6, July 23-27, 2018, if you cancel:

On July 2 or before: You will be charged the \$75 cancellation fee, then you will receive a refund of the remaining funds you have paid.

On July 3-July 15: You will be charged the \$75 cancellation fee, then you will receive a 50% refund of the remaining funds you have paid.

On July 16 or later: NO refund will be issued.

Session 7, July 30-August 3, 2018, if you cancel:

On July 9 or before: You will be charged the \$75 cancellation fee, then you will receive a refund of the remaining funds you have paid.

On July 10-July 22: You will be charged the \$75 cancellation fee, then you will receive a 50% refund of the remaining funds you have paid.

On July 23 or later: NO refund will be issued.

A reserved session may be changed to another session ONCE without penalty. Second session change will incur the \$75 cancellation fee and the new session will be a new registration.

Cancelations 21 days or more before the first day of your reserved session: You will be charged the \$75 cancellation fee, then you will receive a refund of the remaining funds you have paid.

Cancelations 8-20 days before the first day of your reserved session: You will be charged the \$75 cancellation fee, then you will receive a 50% refund of the remaining funds you have paid.

Cancelations 7 days or fewer before the first day of your reserved session: NO refund will be issued.

Refunds will **not** be issued retroactively for campers who miss periods of the camp due to illness, injury, conflicting activities, or any other reason. Penalty applies to both tuition and bus fare.
